# SPECIAL "WHEEL OF FORTUNE" COMPETITION RULES

These rules set out the special conditions and the applicable practical details specific to the Wheel of Fortune Competition. For all other matters, please refer to the "General Competition Rules of the Company", which are attached. These Rules form an integral part of the conditions applicable to the competition and are available on the website www.circus.be<sup>i</sup>.

Participation in this competition constitutes full and unreserved acknowledgement and acceptance of these special rules and the General Competition Rules. Any claims or disputes subsequent to the player's participation on the elements of these will not be accepted.

- A. Competition name: Wheel of Fortune (hereinafter the "Competition")
- **B. Organizer:** CIRCUS BELGIUM S.A. with its head office at 4000 Liège, rue des Guillemins 129, registered under the business number CBE 0451.000.609. (hereinafter the "Company")
- **C. Duration of the Competition:** From 19/08/2024 at 7:00 to 26/08/2024 at 7:00
- D. Competition location: All the CIRCUS CASINO gaming halls, Class II establishments
- **E. Territorial limits:** Belgian territories

## F. Conditions for participation:

- Presence is obligatory within a Circus Casino establishment;
- Full completion of the participation form with all the requested information;
- Throw a dart and succeed in getting it on the target under the supervision of a Circus Casino staff member;
- Placing of the form in the box provided in the Circus Casino gaming halls or handing it to a member of the Circus Casino gaming hall staff who will place it in the box provided;
- Each participant may submit only one entry per day and per person.

#### **G.** The running of the Competition

- **1**. Participation in the Competition is exclusively carried out in person inside the Circus Casino gaming halls by respecting the following process:
  - Fully and correctly complete the Competition participation form with the required personal information. Any non-conforming participation forms (illegible, crossed out, incomplete, ripped, photocopied or another fraudulent act) will automatically invalidate the participation of the player concerned.
  - Take part in the darts game. The player must successfully land a dart on the target to be able to spin the wheel.
  - Spin the wheel and wait for it to stop on one of the segments.
- 2. Determining a winner(s) and attributing prizes

The winnings will be awarded to a participant when they fulfill all the conditions for participation in the Competition according to the winnings indicated on the segment on which the wheel stopped.

The potential prizes are the following:

- Mocktail
- Surprise
- €5
- €10
- €15

From Monday up to and including Saturday, the "rejouez demain" (play again tomorrow) segments will be shown on the wheel: the player does not win a prize but can play again from the following day.

On Sunday, the "rejouez à partir du ..." (play again from...) segments announcing the next dates of the promotion will be shown on the wheel: the player does not win a prize and can try again during the following "Wheel of Fortune" week, the dates for which are indicated on the segment.

If the player wins cash, it will be distributed to the customer by the Circus staff present in the establishment.

## 3. Fixed number of prizes

For the whole duration of the competition, the prizes are limited, which means each day of the competition, there will be:

- A maximum of 150 mocktails per Circus Casino
- A maximum of 150 surprises per Circus Casino
- A maximum of 150 "€5" per Circus Casino
- A maximum of 150 "€10" per Circus Casino
- A maximum of 150 "€15" per Circus Casino

### **H**. Personal data protection

The participants' personal data communicated to the Company as part of the Competition is processed by the Company for marketing purposes (marketing related to offering new games and bets online, including sending text messages, telephone calls, paper or electronic newsletters).

The Company devotes the greatest care to the protection of personal data that the participants provide.
