## SPECIAL RULES FOR THE "DREAM BIG" COMPETITION

These rules set out the special conditions and the practical details specific to the "Dream Big" Competition. For all other matters, please refer to the "General Competition Rules of the Company". These Rules form an integral part of the conditions applicable to the Competition and are available on the website https://www.circus-casino-places.be/i.

Participation in this competition constitutes full and unreserved acknowledgement and acceptance of these special Rules and the General Competition Rules. Any claims or disputes subsequent to the player's participation on the elements of these will not be accepted.

- **A. Competition name:** DREAM BIG (hereinafter the "Competition")
- **B.** Organizer: CIRCUS BELGIUM S.A. with its head office at 4000 Liège, rue des Guillemins 129, registered under the business number CBE 0451.000.609. (hereinafter the "Company")
- **C. Date and duration of the Competition:** the Competition will take place from 25 November 2024 to 21 December 2024. The Competition will end with a special event on 21 December 2024.
- D. Competition location: All the CIRCUS CASINO gaming halls, class II establishments
- E. Territorial limits: Belgian territories

### F. Conditions for participation:

- Presence is obligatory in a CIRCUS CASINO establishment within which this Competition is taking place;
- Correctly answer the general knowledge question written on the participation ticket between 25 November 2024 and 21 December 2024;
- Put the participation ticket in one of the boxes provided inside the CIRCUS CASINO establishment.

#### E. The running of the Competition:

Participation tickets for the Competition will be handed out for the duration of the Competition (from 25 November 2024 to 21 December 2024) for every daily visit in a CIRCUS CASINO establishment of every participant:

- From Monday, 25 November 2024 up to and including Monday, 9 December 2024: 1 visit = 4 tickets / day / person
- From Tuesday, 10 December 2024 up to and including Saturday, 21 December 2024: 1 visit = 8 tickets / day / person

Each participant must correctly answer the general knowledge question written on the participation ticket. Each participant must then place the duly completed participation ticket in the box located inside the CIRCUS CASINO establishment. There will be several boxes, each determining a range of possible answers to the additional question. The participant must select the box corresponding to the

answer they believe is the correct one to the additional question. Placing a participation ticket inside the chosen box equates to giving a clear and definitive answer to the additional question.

- On the day of the promotion, namely 21 December 2024, the Competition will end with a special "DREAM BIG" event in all the CIRCUS CASINO establishments simultaneously. During this event, the box corresponding to the right answer to the additional question will be opened.
