

SPECIAL RULES FOR THE BINGO CONTEST

These rules set out the special conditions and the practical details specific to the “Bingo” Contest. For all other matters, please refer to the “General Competition Rules of the Company”. These Rules form an integral part of the conditions applicable to the Contest and are available on the website <https://www.circus-casino-places.be>.

Participation in this Contest constitutes full and unreserved acknowledgement and acceptance of these special Rules and the General Competition Rules. Any claims or disputes subsequent to the participant's participation on the elements of these will not be accepted.

A. Contest name: Bingo (hereinafter the “Contest”)

B. Organizer: CIRCUS BELGIUM S.A. with its head office at 4000 Liège, rue des Guillemins 129, registered under the business number CBE 0451.000.609. (hereinafter the “Company”)

C. Date and duration of the Contest: the Contest will take place on 5 April 2025.

D. Contest location: All the CIRCUS CASINO gaming halls, class II establishments

E. Territorial limits: Belgian territories

F. Conditions for participation:

- Presence is obligatory in a CIRCUS CASINO establishment within which this Contest is taking place.

E. The running of the Contest:

On 5 April 2025, the day of the event, the Contest will start with the simultaneous distribution of Bingo cards in all the CIRCUS CASINO establishments.

Each participant will receive four (4) different colored grids, corresponding to the four (4) planned games.

Each game will have three (3) objectives: line, two lines and a full house. As soon as a participant reaches an objective, they must immediately shout “Bingo!” and report to the host before the next ball is drawn.

The host will then check the validity of the grid. If it is correct, the participant must complete a physical skill test, the terms of which will be specified on site by the staff. If successful, the prize will be awarded. If they fail, the prize will be added to that of the next objective. If the participant fails the test to win the “full house” prize, the competition will continue until there is another winner.

In the event of a tie, the participants concerned must pass the physical fitness test and share the prize equally.

The same participant can win several prizes during the Contest.

Once an objective has been validated and the prize awarded, any late claims by another participant claiming to have also reached the objective will not be taken into account.

The organizer reserves the right to modify the terms and conditions of the Contest at their sole discretion.

2. Determining a winner(s) and attributing prizes

The list of prizes is for information only:

1 line = €100

2 lines = €150

1 full house = €250

The prizes will be available to collect from 6 April until 30 April 2025 in the CIRCUS CASINO establishment where they were won.

H. Personal data protection

The participants' personal data communicated to the Company as part of the Competition is processed by the Company for marketing purposes (marketing related to offering new games and bets online, including sending text messages, telephone calls, paper or electronic newsletters).

The Company devotes the greatest care to the protection of personal data that the participants provide.
